## On The Day of Judgment

All humans will stand before God to be judged one day. Hebrews 9:27 says, "... it is appointed for men to die once, but after this the judgment." Hebrews 6:2 lists "eternal judgment" among the most fundamental teachings of Christianity. Romans 14:12 declares, "So then each of us shall give account of himself to God." This accounting will involve everything that we have done in our life: "For we must all appear before the judgment seat of Christ, that each one may receive the things done in the body, according to what he has done, whether good or bad" (2 Corinthians 5:10).

The Christian has an advantage on the Day of Judgment: He has Christ Jesus in His corner. All sin, but Jesus is the Christian's advocate: "My little children, these things I write to you, so that you may not sin. And if anyone sins, we have an Advocate with the Father, Jesus Christ the righteous" (1 John 2:1). While Jesus advocates for the Christian, He will judge the non-Christian. Paul declared in Acts 17:30-31: "Truly, these times of ignorance God overlooked, but now commands all men everywhere to repent, because He has appointed a day on which He will judge the world in righteousness by the Man whom He has ordained. He has given assurance of this to all by raising Him from the dead."

There is a judgment; Jesus is the judge; and His word will be the standard of judgment. In John 12:48, Jesus said, "He who rejects Me, and does not receive My words, has that which judges him-the word that I have spoken will judge him in the last day." Learn Christ's words so that you may be found approved!



# The Pain of Silence

"When I kept silent about my sin, my body wasted away through my groaning all day long. For day and night Your hand was heavy upon me; My vitality was drained away as with the fever heat of summer. Selah" (Psalm 32:3, 4).

When David had lived as an impenitent person, an indescribable misery gripped him. He relates his pain: "When I kept silent about my sin, my body wasted away through my groaning all day long." Nothing can disturb one's tranquility like trying to conceal sin or refusing to repent of sin. During the time that David had tried to hide his sin, he had become more and more beaten down by his sin. His whole body had seemed to rebuke him because of his transgressions. In figurative exaggeration, he describes his body as wasting away or falling apart from the heavy strain of the load of his guilt. Instead of confessing his sin, he had been "groaning" or roaring "all day long." He must have complained about the severity of his pain, with his complaints surfacing as a continual moaning over his plight and situation. Instead of fixing the problem, he had roared about it with the whines of distress. He asserts, "For day and night Your hand was heavy upon me." The torment of his guilt had revealed itself in both mental and bodily agony. "Day and night" he had been burdened with grief. The NASB translates the second part of this verse, a difficult Hebrew sentence,

"My vitality was drained away as with the fever heat of summer." The idea is that the moisture of his body had dried up as water does in a drought. His body had deteriorated, and his spirit had been immersed in torment and sorrow. He says that God's "hand was heavy upon" him. God used this pain to turn his mind toward godly sorrow.

Key Thought: Remorse, a hurting conscience, and the inability to sleep were built-in rebukes from God. They seemed to point divine fingers at him and say, "You have sinned, and you need to repent!" The word Selah must conclude the thought and is an indication that the reader should spend some time thinking about this truth.
